## ONLINE PRIVACY POLICY AGREEMENT

### **Why We Collect Information and For How Long**

We are collecting your data for several reasons:

MBJI greatly respects your privacy. ### Children under the age of 13

MBJI' website is not directed to, and does not knowingly collect personal identifiable information from, children under the age of thirteen (13). ### **Notice to European Union Users**
